EMERGENCY PROCEDURES

IF THIS HAPPENS	DO THIS
Tanker/Vehicle Accident	Switch off engine and electrical equipment. Keep people away, warn other traffic. Check for spills. Call the Emergency Services: Dial 111.
Spill or leak	Wear overalls, chemical resistant gloves and dust mask. Prevent further spillage. Sweep up spilled product and place in sealable container for disposal. Avoid raising dust. Wash down affected area with water plus detergent. Absorb and collect washings and place in the same sealable container for disposal. Seek advice from the local authority regarding disposal.
Fire	Call the Fire Service: Dial 111. Wear protective clothing and breathing apparatus. During a fire, toxic fumes can be released. Extinguish warehouse fires with water spray, dry powder, or foam. Contain run-off. Keep non-involved persons away.

FIRST AID

If Swallowed:	Rinse mouth and then drink plenty of water. For advice contact the National Poisons Centre 0800 POISONS (0800 764 766) or a doctor.
If in Eyes:	Rinse cautiously with water for at least 15 minutes with eyelids held open. Remove contact lenses, if present and easy to do. Continue rinsing.
If on Skin:	Remove contaminated clothing and wash skin with plenty of soap and water. Do NOT scrub the skin. Wash clothing before reuse.
If Inhaled:	Remove to fresh air and keep at rest in a position comfortable for breathing. Get medical advice/attention if you feel unwell.

STORAGE AND SEGREGATION

Storage: Store in the closed, original container, in a cool, dry well-ventilated area, safe place, away from direct sunlight, away from children, animals, feed or foodstuffs.

AGGREGATE STORAGE VOLUME THRESHOLDS: When stored with substances of the same hazard the aggregate quantity must be considered. For full details refer to the current standard NZS8409 Management of Agrichemicals or the HSNO Regulations.
