APPROVALS FOR LICENSED MEAT PREMISES AND FOOD/DAIRY FACTORIES

The following BASF products have been approved by the Ministry for Primary Industries (MPI) for use as maintenance compounds in **Licensed Meat, Fish, Game and Game Meat Premises**, and in **Farm Dairies** and **Dairy Processing Premises** when used in accordance with the label instructions. These approvals are issued for a period of 5 years, after which time they are due for revalidation.

GOLIATH® COCKROACH GEL (Insecticide)

MPI Approved Type D (All animal product except dairy)

GOLIATH COCKROACH GEL is approved for use in premises processing all animal product except dairy (meat, fish, game and game meat premises) operating under the Animal Products Act regime. Code: Type D. This approval is valid until 26 Apr 2029.

Conditions:

1. GOLIATH Cockroach Gel may be used in food areas according to the manufacturers instructions as to use. Before using, all unpackaged food and packing material must be removed from the room. After use, the room must be thoroughly cleaned.

GOLIATH COCKROACH GEL is approved for use in farm dairies and dairy processing premises when used in accordance with the label instructions. This approval is valid until 10 May 2029.

Conditions - Farm Dairy Use:

2. Must not be used in milk or food handling areas
3. For use outside food areas or for spot use in food areas while out of production for at least 7 days
4. Bait must not be accessible to animals other than the target pest

FENDONA® 15SC (Insecticide)

MPI Approved Type B (All animal product except dairy)

FENDONA 15SC is approved for use in premises processing all animal product except dairy (meat, fish, game and game meat premises) operating under the Animal Products Act regime. Code: Type B. This approval is valid until 2 May 2029.

Conditions:

1. This insecticide is not permitted in any edible product area or any area where edible product or packaging material is stored.
2. It must be used in a manner that prevents the entry of the insecticide into edible product areas or stores containing packaging material.

MPI Approved for Use in Farm Dairies and for Use in Dairy Processing

FENDONA 15SC is approved for use in farm dairies and dairy processing premises when used in accordance with the label instructions. This approval is valid until 10 May 2029.

Conditions - Farm Dairy Use:

1. To be used in accordance with label instructions.
2. Must not be used on milk contact surfaces.
3. Must not be used in areas where milk is exposed or stored, including milking and milk storage areas.
4. Animal feed contact surfaces must be rinsed after use of this product.
5. Must not be used around milking animals.
6. The surrounding area must be out of service and well ventilated during application/use.
7. Milk contact surfaces in the vicinity of the farm dairy must be cleaned and rinsed after use.

Conditions - Dairy Processing:

1. To be used in accordance with label instructions.
 2. Not to be used on food contact surfaces.
 3. Must not be used in areas where milk, dairy material, product or ingredients are processed.
 4. Should incidental contact with milk or food surfaces occur, the surfaces must be thoroughly cleaned and rinsed to ensure no residue remains.
 5. The food area must be out of service and ventilated during application.
 6. No contact with food or food contact surfaces permitted.
 7. This product must not be used on food or food packaging contact surfaces.

RIPCORDER (Insecticide)

MPI Approved Type B (All animal product except dairy)

RIPCORDER is approved for use in premises processing all animal product except dairy (meat, fish, game and game meat premises) operating under the Animal Products Act regime. Code: Type B. This approval is valid until 17 Apr 2030.

Conditions:

1. This insecticide is not permitted in any edible product area or any area where edible product or packaging material is stored.
2. It must be used in a manner that prevents the entry of the insecticide into edible product areas or stores containing packaging material.

MPI Approved for Use in Farm Dairies and Dairy Processing

RIPCORDER is approved for use in farm dairies and dairy processing premises when used in accordance with the label instructions. This approval is valid until 24 Oct 2030.

Conditions - Farm Dairy and Dairy Processing Use:

1. To be used in accordance with label instructions.
 2. Not for use on or near food contact surfaces or in areas where food contact surfaces are exposed (including, in farm dairies, milking and milk storage areas).
 3. Area to be well-ventilated after application.
 4. Must not be used in a manner that may result in edible ingredients, product and packaging becoming contaminated.
 5. All edible ingredients, product and packaging must be removed, isolated or covered before use (including protection from odours).
 6. Should incidental contact with food contact surfaces occur, surfaces must be cleaned and thoroughly rinsed to ensure no residue remains.
 7. In farm dairies, animal feed must be removed and feed contact surfaces must be rinsed after use.
 8. In farm dairies, bait, when used, must not be accessible to milking animals.
 9. Not for use near milking animals except when used in accordance with ACVM approval/ registration.
 10. For manufacturing areas, may only be used in accordance with documented pest management procedures

RIPCORDER XTRA (Insecticide)

MPI Approved Type B (All animal product except dairy)

RIPCORDER XTRA is approved for use in premises processing all animal product except dairy (meat, fish, game and game meat premises) operating under the Animal Products Act regime. Code: Type B. This approval is valid until 27 Mar 2031.

Conditions:

1. This insecticide cannot be used in food or edible areas or any area where food or edible product or food contact packaging material is stored.
2. This must be used in a manner that prevents the entry of the insecticide into food or edible areas.

MPI Approved for Use in Farm Dairies and Dairy Processing

RIPCORDER XTRA insecticide is approved for use in farm dairies and dairy processing premises when used in accordance with the label instructions. This approval is valid until 8 Nov 2026.

Conditions - Farm Dairy Use:

1. To be used in accordance with label instructions.
2. Must not be used on milk contact surfaces.
3. Must not be used in areas where milk is exposed or stored, including milking and milk storage areas.
4. Animal feed contact surfaces must be rinsed after use of this product.
5. Must not be used around milking animals.
6. The surrounding area must be out of service and well ventilated during application/use.
7. Milk contact surfaces in the vicinity of the farm dairy must be cleaned and rinsed after use.

Conditions - Dairy Processing:

1. To be used in accordance with label instructions.
 2. Not to be used on food contact surfaces.
 3. Must not be used in areas where milk, dairy material, product or ingredients are processed.
 4. Should incidental contact with milk or food surfaces occur, the surfaces must be thoroughly cleaned and rinsed to ensure no residue remains.
 5. The food area must be out of service and ventilated during application.
 6. No contact with food or food contact surfaces permitted.
 7. This product must not be used on food or food packaging contact surfaces.

SECLIRA® WSG (Insecticide)

MPI Approved Type B (All animal product except dairy)

SECLIRA WSG is approved for use in premises processing all animal product except dairy (meat, fish, game and game meat premises) operating under the Animal Products Act regime. Code: Type B. This approval is valid until 23 Jun 2031.

Conditions:

1. This insecticide cannot be used in food or edible areas or any area where food or edible product or food contact packaging material is stored.
2. This must be used in a manner that prevents the entry of the insecticide into food or edible areas.

MPI Approved for Use in Farm Dairies and Dairy Processing

SECLIRA WSG insecticide is approved for use in farm dairies and dairy processing premises when used in accordance with the label instructions. This approval is valid until 26 Jun 2031.

Conditions - Farm Dairy Use and Dairy Processing:

1. This must be used in accordance with label instructions.
2. This must not be used on or near milk or food contact surfaces, or where milk or food contact surfaces are exposed, including milking and milk storage areas.
3. This must not be used near milking animals except when used in accordance with ACVM approval. Bait must not be accessible to milking animals.
4. This must be used in a way that ensures milk, food and food contact packaging are not contaminated.
5. Before use, all milk, food, food contact packaging and animal feed must be removed, isolated or covered (and protected from odours).
6. The processing area must be well ventilated after use.
7. If incidental contact with a milk, food or animal feed contact surface occurs, the surface must be cleaned and thoroughly rinsed with suitable water to ensure no residue remains.
8. For manufacturing areas, this must be used in accordance with a pest control programme that has been documented to relevant MPI legislation.

SECLIRA® Pressurised Bait (Insecticide)

MPI Approved Type B (All animal product except dairy)

SECLIRA WSG is approved for use in premises processing all animal product except dairy (meat, fish, game and game meat premises) operating under the Animal Products Act regime. Code: Type B. This approval is valid until 17 Aug 2031.

Conditions:

1. This insecticide cannot be used in food or edible areas or any area where food or edible product or food contact packaging material is stored.
2. This must be used in a manner that prevents the entry of the insecticide into food or edible areas.

MPI Approved for Use in Farm Dairies and Dairy Processing

SECLIRA WSG insecticide is approved for use in farm dairies and dairy processing premises when used in accordance with the label instructions. This approval is valid until 6 Aug 2031.

Conditions - Farm Dairy Use and Dairy Processing:

1. This must be used in accordance with label instructions as an insecticide.
2. This must be used in a way that ensures milk, food and food contact packaging are not contaminated.
3. Before use, all milk, food and food contact packaging must be removed, isolated or covered (and protected from odours).
4. The processing area must be out of service during use.
5. After use, milk and food contact surfaces must be cleaned and thoroughly rinsed with suitable water prior the next milking or before production starts.
6. For manufacturing areas, this must be used in accordance with a pest control programme that has been documented to relevant MPI legislation.

SELONTRA® SOFT BAIT (Rodenticide)

MPI Approved Type C (All animal product except dairy)

SELONTRA SOFT BAIT rodenticide is approved for use in premises processing all animal product except dairy (meat, fish, game and game meat premises) operating under the Animal Products Act regime. Code: Type C. This approval is valid until 3 Jul 2028.

Conditions:

1. This pesticide may only be used in premises according to the requirements of a pest control programme which has been documented to relevant MPI legislation.
2. It may be used in food areas provided there is no exposed product or food ingredient present in the room.
3. It must be removed from edible areas before processing operations commence.

MPI Approved for Use in Farm Dairies and Dairy Processing

SELONTRA SOFT BAIT rodenticide is approved for use in farm dairies and dairy processing premises when used in accordance with the label instructions. This approval is valid until 26 Jun 2028.

Conditions - Farm Dairy Use:

1. To be used in accordance with label instructions as a rodenticide.
2. Use only with an appropriate bait station

Conditions - Dairy Processing:

1. To be used in accordance with label instructions as a rodenticide.
 2. Use only with an appropriate bait station

STORM® SECURE (Rodenticide)

MPI Approved Type C (All animal product except dairy)

STORM SECURE is approved for use in premises processing all animal product except dairy (meat, fish, game and game meat premises) operating under the Animal Products Act regime. Code: Type C. This approval is valid until 6 Mar 2029.

Conditions:

1. This pesticide may only be used in premises according to the requirements of a pest control programme which has been documented to relevant MPI legislation.
2. It may be used in food areas provided there is no exposed product or food ingredient present in the room.
3. It must be removed from edible areas before processing operations commence.

MPI Approved for Use in Farm Dairies and Dairy Processing

STORM SECURE rodenticide is approved for use in farm dairies and dairy processing premises when used in accordance with the label instructions. This approval is valid until 29 May 2029.

Conditions - Farm Dairy and Dairy Processing Use:

1. Must be used in accordance with label instructions.
 2. Must not be used in milk or food handling areas.
 3. Bait to be laid in recorded locations, preferably using a bait station.
 4. Bait must not be accessible to milking animals, other food producing animals, children or pets.

TERMIDOR® 100SC (Insecticide)

MPI Approved Type B (All animal product except dairy)

TERMIDOR 100SC is approved for use in premises processing all animal product except dairy (meat, fish, game and game meat premises) operating under the Animal Products Act regime. Type B. This approval is valid until 17 Apr 2030.

Conditions:

1. This insecticide is not permitted in any edible product area or any area where edible product or packaging material is stored.
2. It must be used in a manner that prevents the entry of the insecticide into edible product areas or stores containing packaging material.

MPI Approved for Use in Farm Dairies and Dairy Processing

TERMIDOR 100SC is approved for use in farm dairies and dairy processing premises when used in accordance with the label instructions. This approval is valid until 24 Oct 2030.

Conditions - Farm Dairy and Dairy Processing Use:

1. To be used in accordance with label instructions.
2. Not for use on or near food contact surfaces or in areas where food contact surfaces are exposed (including, in farm dairies, milking and milk storage areas).
3. Area to be well-ventilated after application.
4. Must not be used in a manner that may result in edible ingredients, product and packaging becoming contaminated.
5. All edible ingredients, product and packaging must be removed, isolated or covered before use (including protection from odours).
6. Should incidental contact with food contact surfaces occur, surfaces must be cleaned and thoroughly rinsed to ensure no residue remains.
7. In farm dairies, animal feed must be removed and feed contact surfaces must be rinsed after use.
8. In farm dairies, bait, when used, must not be accessible to milking animals.
9. Not for use near milking animals except when used in accordance with ACVM approval/ registration.
10. For manufacturing areas, may only be used in accordance with documented pest management procedures.
